



## Terms & conditions Wageningen Soil Conference 2023 (WSC 2023)

### Acceptance of terms and conditions

1. Submission of a registration is regarded as affirmation of your acceptance of these terms & conditions. Should you not wish to accept the terms & conditions you should not register.

### Liability

1. The organizer, directors, agents and personnel of the event or complex are not liable for loss of any kind resulting from damage to or the loss of private property, nor for loss due to any other defects to the accommodation or surrounding land, nor for loss resulting from any disaster, or loss to property or persons howsoever else incurred.
2. The participant is liable for all loss of any kind caused in any way by its own act or omission or that of others, to property or persons who work for the organizers, and must indemnify the organizers and personnel against any third-party claim that could be brought against the organizers and the personnel.

### Payment terms

1. Participants of the WSC2023 will pay the organizer a participant fee as specified on the website: <https://wageningensoilconference.eu/2023/>. Accommodation and travel costs are not included in the conference registration fee. Participants are responsible for making their own lodging and travel arrangements. Any and all other costs associated with participant's attendance (including without limitation any travel and/or accommodation expenses) shall be borne solely by participant and organizer shall have no liability for such costs.
2. The total participation costs (registration fee and if applicable, the separate costs for participation in conference dinner) must be made as single payment:
  - 100% of the participation costs must be paid at the time of registration.
  - If the registration is dated less than 14 days prior to the start of the event, the participation costs must be paid immediately to the organizer or after consultation with the organizer; the participant must be able to show a proof of payment at the registration desk.
3. If a participant fails to pay the amount owed within the specified period, the organizer is entitled to refuse access to the event, without prejudice to the entitlement of the organizer to seek full payment of the said amount. On-site registration payment is not possible.
4. Payment must be done during registration in the registration system. All costs of (foreign) bank transfers are being paid for by the participant.

### Cancellation terms

#### A. Cancellation terms participants

1. Registration cannot be withdrawn or altered by the participant without prior notice of cancellation addressed to [wageningensoilconference@wur.nl](mailto:wageningensoilconference@wur.nl).
2. If a cancellation notice, for good reasons (force majeure), is sent:
  - before 17 July 2023: the participant will be refunded the full participation costs, less expenses (see 3).
  - from 17 July 2023 to 1 August 2023: the participant will be refunded 50% of the participation costs, less expenses (see 3).
  - from 1 August 2023 onwards, the participant is liable to pay 100% of the participation costs. Cancellations after 31 July 2023 and no-shows are not eligible for a refund.
  - There is no reason (including but not limited to illness of any kind, including Covid, inability to travel, visa application rejection, travel restrictions, etc.) for registration cancellation that makes the above-mentioned deadline for cancellations inapplicable.
3. The participant is liable to pay an administration fee of 40 euro which will be deducted from the amount to be refunded.
4. If a participant is not able to attend the WSC 2023 it is possible to send a replacement, subject to sending a prior written request to the organizers.
5. If there is an urgent or compelling reason, the organizer is entitled to deny the relevant person access to the event.
6. In the case of any right to restitution, payment will be made to the participant after the event.



## B. Cancellation terms organization

1. Should, in any case, for good reasons (force majeure, including unforeseen restrictions due to pandemics) the WSC2023 – in total – be cancelled, the following will apply:
  - The paid participation fee will be reimbursed to the participant, minus an administration fee of 40 euro. After August 1 2023, the costs for the Conference dinner cannot be reimbursed.
  - Wageningen University and ISRIC are not liable for any costs (i.e. travel costs, hotel costs or any other) made by the participant for this conference. Participants are, therefore, advised to arrange appropriate insurance coverage. This should apply not only to travel and health insurance but also to cancellation costs.

## Visa

The WSC 2023 secretariat will issue invitation letters for visa application for participants on request after receipt of the full registration costs. Due to possible delays in visa processing we advise early registration. In the event of visa rejection, a refund of the registration fee with a deduction of an administration fee of 40 euro will be made upon receipt of an official decision letter before 17 July 2023. From 17 July 2023 onwards a 50% refund will be available up to and including 31 July 2023, after which no refund is available.

By registering, participants acknowledge and consent that during their attendance at WSC2023 their image or voice may be recorded via video, photograph, or by any other means by an official of the conference or Wageningen University. This content may be distributed or published at the discretion of WSC2023 organization.
